

## Bermuda Public Companies Update January 2020



This edition of the Bermuda Public Companies Update summarises significant transactions involving Bermuda public companies in the second half of 2019. Conyers is consistently recognised as the leading Bermuda law firm advising Bermuda public company issuers and underwriters. 2019 was another busy year for Conyers in this space as we were fortunate to be instructed on more mandates involving Bermuda public companies than any other firm.

### Global market update

Geopolitical factors including US-China trade tension, Brexit and Hong Kong unrest impacted markets worldwide in 2019: global IPO activity fell by 20% and the total value of capital raised fell by 8%. However, while the number of domestic US IPOs also dropped by 20%, the total US IPO value increased 31% over 2018 due to some landmark deals such as Uber, Avantor and Lyft.<sup>1</sup>

M&A activity remained generally robust in 2019 despite the uncertainties, particularly in the US which saw 15 of the 20 largest deals. Cross-border M&A saw a significant drop, representing just 30% of global volume in 2019, the lowest share in ten years.

### Bermuda companies update

Some US\$19.5 billion in capital was raised in 2019 by Bermuda companies listed on the NYSE and Nasdaq, with the second half of the year performing significantly better than the first half. This is up from US\$13.2 billion in 2018.

M&A activity accounted for more than 20 of the transactions involving Bermuda public companies in H2 2019. In this issue we feature one of the biggest of those deals – Aircastle’s US\$7.4 billion acquisition by Marubeni and Mizuho. Another big-ticket M&A deal was Central European Media Enterprises’ agreement to be acquired by an affiliate of

PPF Group N.V. in a cash transaction valued at approximately US\$2.1 billion.

There was one Bermuda company IPO on a US exchange in the period – Borr Drilling Limited began trading on the New York Stock Exchange on 31 July 2019 under the ticker symbol BORR, issuing 5,750,000 shares at a price of \$9.30 per share and raising over US\$53 million. This is a secondary listing – the company continues its primary listing on the Oslo Børs under the ticker BDRILL.

We hope this update on Bermuda public companies market activities will be of interest to our legal colleagues, clients and Bermuda market followers.

- **Brookfield Infrastructure Partners L.P.** (NYSE: BIP) entered into a subscription agreement with Brookfield Asset Management Inc. for a private placement of 6,128,000 redeemable partnership units at US\$40.80 per unit for gross proceeds of US\$250 million. (July)
- **SFL Corporation Ltd.** (NYSE:SFL) completed a US\$11.6 million public offering. (July)
- **Cosan Limited** (NYSE:CZZ) completed a US\$750 million offering of 5.5% senior unsecured notes due 20 September, 2029. (July)
- **Brookfield Infrastructure Partners L.P.** (NYSE: BIP) completed a US\$500 million offering and concurrent private placement. (July)
- **Aspen Insurance Holdings Limited** (NYSE: AHL) issued 10,000,000 depository shares for US\$250 million. (August)

- **Urovant Sciences Ltd.** (NasdaqGS: UROV) entered into a definitive agreement to sell a 75.3% stake to Sumitomo Dainippon Pharma Co., Ltd. for an undisclosed amount. (September)

## Aircastle acquired by Marubeni and Mizuho in US\$7.4 billion deal



Aircastle Limited (NYSE:AYR) entered a definitive agreement in November 2019 to be acquired by a newly-formed entity controlled by affiliates of Marubeni Corporation and Mizuho Leasing Company Limited. Under the terms of the merger agreement, Aircastle shareholders will receive US\$32.00 in cash for each common share of Aircastle (other than shares already owned by Marubeni and its affiliates), representing a total valuation of approximately US\$2.4 billion, or approximately US\$7.4 billion including debt obligations to be assumed or refinanced net of cash.

The transaction is subject to customary closing conditions, including approval by Aircastle's shareholders and receipt of certain regulatory approvals, and is expected to close in the first half of 2020. Marubeni has agreed to vote the common shares of Aircastle that Marubeni and its affiliates beneficially own in favour of the transaction.

Citigroup Global Markets Inc. is acting as the exclusive financial advisor to Aircastle. Conyers Bermuda office advised on the matter, working alongside Skadden, Arps, Slate, Meagher & Flom LLP.

Aircastle Limited acquires, leases and sells commercial jet aircraft to airlines throughout the world. As of 30 September, 2019, Aircastle owned and managed on behalf of its joint ventures 277 aircraft leased to 87 customers located in 48 countries.

- **Marvell Technology Group Ltd.** (NasdaqGS:MRVL) completed its acquisition of Aquantia Corp. for approximately US\$540 million. (September)
- **Central European Media Enterprises Ltd.** (NasdaqGS:CETV) entered into a definitive agreement to be acquired by an affiliate of PPF Group N.V. in a cash transaction valued at approximately US\$2.1 billion. (October)
- A consortium of local entrepreneurs acquired Cable & Wireless (Seychelles) Limited from **Liberty Latin America Ltd.** (NasdaqGS:LILA) for an enterprise value of approximately US\$100 million. (October)
- **Urovant Sciences Ltd.** (NasdaqGS:UROV) entered into an Open Market Sales Agreement with Jefferies LLC., whereby common shares having an aggregate offering price of up to US\$50 million may be offered and sold. (November)
- Citigroup Inc. acquired an approximate 9% stake in **VEON Ltd.** (NasdaqGS:VEON) from Telenor ASA for US\$362 million. (November)
- **Watford Holdings Ltd.** (NasdaqGS:WTRE) announced it entered into a share purchase agreement to acquire Axeria IARD S.A. from April SA. (December)
- **Arch Capital Group Ltd.** (NasdaqGS:ACGL) entered into an agreement to acquire Barbican Group Holdings Limited from funds managed by Carlson Capital, L.P. (December)

## Sagicor Financial Company Ltd – new on the Toronto Stock Exchange

Sagicor Financial Corporation Ltd completed a business combination transaction with Alignvest Acquisition II Corporation in December 2019 that resulted in a new Bermuda entity Sagicor Financial Company Ltd (Sagicor) which subsequently listed on the Toronto Stock Exchange, trading under the ticker "SFC". Conyers advised Sagicor on the deal. This brings the number of Bermuda companies with primary listings on the TSX to three, the others being Brookfield Renewable Partners (TSX:BEP.UN) and Sunwah International Limited (TSX:SWH).
